Texas Department of Motor Vehicles

2017 was a busy year at the Texas Department of Motor Vehicles (TxDMV). In the past year we celebrated the 100th anniversary of the license plate and launched a first-of-its-kind system that moved the motor vehicle and salvage dealer licensing system online. We replaced over 2,975 county workstations and 2,973 printers with a 97.7% county satisfaction rating. In addition, when Hurricane Harvey hit, the department coordinated with Governor Abbott on the suspension of certain statutes related to the enforcement of registration and title laws for 48 affected counties. Since Nov. 30, 2017, TxDMV has processed over 200,000 salvage and non-repairable titles, many of which were the result of damage caused by Harvey. As we begin a new

year, TxDMV is working to continue creating, developing, and enhancing tools, processes, and systems in order effectively partner with tax-assessor collectors in serving the motoring public.

Below is a summary of a few of the current areas in which TxDMV is focused as we begin 2018.

Registration And Titling System (Rts)

TxDMV continues to deploy new releases to the refactored Registration and Titling System (RTS) in order to accommodate new legislation and upgrade functionality. Soon TxDMV will

deploy an update to RTS that will allow county users to include inactive and archived records when searching for records by customer name. This update also includes the new Package Delivery license plate, designed for package delivery service companies who want to utilize small vehicles such as golf carts, utility vehicles, neighborhood electric vehicles, etc., for package delivery. Additionally, there are new specialty license plates and voluntary contribution options. More information on this RTS release will be available in upcoming training webinars and release notes.

eTAG/webDEALER Update

Currently TxDMV is working to move eTAG (the system used for Buyer Tags) into webDEALER (the title application system). Once complete, dealers or other motor vehicle industry licensees will log into webDEALER to create Buyer Tags (or other tags). If they are also webDEALER users, they will be able to submit a title application without logging in to a different system. Additionally, users will be able to pay for Buyer Tags for out of state purchasers online via credit card. For more information visit www.TxDMV. gov/dealers/eTAG/resources.

New Division Coming To Txdmv

The department is pleased to announce the establishment of the new Compliance and Investigations Division (CID). The goal of CID is to strengthen our efforts to prevent and detect fraud, waste and abuse. CID will process complaints and investigate allegations of fraud related to motor vehicle title and registration, provide support for law enforcement, and work on compliance education and initiatives with our regional service centers and tax assessor-collectors' offices.

The department has hired Tim Menke to serve as the director of CID. Tim will start on Tuesday, January 2, 2018, and he brings over 25 years of experience in the field of fraud, waste, and abuse with him. One of his first orders of business will be to hire additional staff to help the department achieve its goals. Tim will also inherit several key staffers from the Vehicle Titles and Registration (VTR) division including the Field Service Representatives (FSRs) and the department's sole title investigator, Robert Foster.

Sunset Review

TxDMV is currently undergoing its first Sunset review. Over the past few months, department staff have met with Sunset staff to provide a more in-depth look at TxDMV's functions, look at the overall purpose, goals and objectives of each of our programs and how each of the programs accomplishes the department's goals. Sunset staff will also be reaching out to our stakeholders, including the tax assessor-collectors, in an effort to better understand TxDMV and how we serve the motoring public.

After gathering as much information as necessary, the Sunset review team will put together a Staff Report that makes specific recommendations for positive change. Sunset anticipates that the Staff Report will be published this spring, potentially as early as April. TxDMV has posted information about the Sunset review process on our website, including a link to Sunset's website where members of the public can view our Self Evaluation Report. We have also provided information about how individuals can contact the Sunset Commission directly if they would like to share their thoughts about the department.



Distinguished Service Award




V. G. Young Conference
