

#### **MARINE DEALER LICENSING - BACKLOG**

For those not already aware, the Boat Section at Texas Parks and Wildlife Department (TPWD) headquarters in Austin has been required to shut down for two weeks due to COVID-19 related issues. Phones banks remain operational, handled by staff who are teleworking, but all other services are temporarily on hold.

Boat Titling, Registration & Marine Licensing

As a result, some Marine License renewal applications have been delayed. For the next 30 days, if a transaction is presented in your office that is processable in every respect, but BRITS advises the dealer license was not Active on the date of sale, please do not reject the customer's transaction. Instead, please contact your TPWD Field Liaisons at 512-389-4393 for assistance. We will review the license information, including pending applications received in our office, and provide guidance accordingly.

#### **BOAT/OUTBOARD MOTOR TAX PENALTY AND INTEREST**

We have received numerous questions related to potential extension periods or waivers for boat/outboard motor tax as a result of COVID-19. TPWD does <u>not</u> have the authority to waive or exempt tax penalty or interest due in the event tax was not paid within the timeframe required by law. Tax law and all related tax policy is under the sole authority of the Texas Comptroller of Public Accounts (CPA).

The CPA has advised that the Governor's original proclamation was specific to motor vehicles and would <u>not</u> apply to boats and outboard motors.

Therefore, all pre-existing tax policies remain in place. TPWD and all participating agents are required by law to collect tax for vessels/boats (115 feet or less in length) and outboard motors purchased in Texas, or brought into Texas, on or after January 1, 2000.

The tax rate is 6.25% of the sales price and is due:

- Within 45 working days from the date of sale or date brought to Texas when purchased on or after September 1, 2019, or
- Within 20 working days from the date of sale or date brought to Texas when purchased prior to September 1, 2019.

Applications filed after the date the tax is due are subject to tax penalties and interest. Applications mailed to TPWD or participating agent offices are considered "filed" when placed in the mail and will be given credit for the postmark date when determining tax due.

**NOTE**: If they choose, a taxpayer may submit Form 57-200 (<a href="https://comptroller.texas.gov/forms/57-200.pdf">https://comptroller.texas.gov/forms/57-200.pdf</a>), Texas Claim for Refund of Boat and Boat Motor Tax, **to the CPA** to request a refund of penalty / interest paid.

#### **COVID-19 Update**

As Texas continues to address issues surrounding the coronavirus pandemic, the department wants to thank the county tax assessor-collectors for their cooperation and patience during these challenging times. The health and safety of the motoring public, employees and stakeholders is of utmost importance while we continue to provide needed services. Please don't hesitate to contact your regional service center manager with any questions or concerns.

#### **Digital License Plate Project**

Digital license plates are electronic devices, like tablets that display a vehicle's license plate number, plate design, and registration expiration. The Texas Department of Motor Vehicles (TxDMV) Board adopted administrative rules related to Texas digital license plates on June 11. Adoption of the rules was mandated by Senate Bill 604, enacted by the 86th Legislature, and allows the department to proceed with a Request for Proposal (RFP) procurement for one or more vendors and offer for sale a digital license plate that may be displayed on eligible vehicles. Eligible vehicles include commercial fleet vehicles, vehicles owned by a government entity, and vehicles that are not registered as passenger vehicles.

Before digital license plates are implemented, the vendor's digital license plate will be tested to ensure the electronic display meets or exceeds the readability, legibility, and other standards required for metal license plates. The department's systems will be programmed to allow for digital license plate remarks on the vehicle record, so law enforcement can verify the status of a digital license plate. Communications will be distributed to your offices, law enforcement, and other stakeholder groups with further information before digital license plates may be displayed on vehicles. The program is scheduled to go-live in December 2020.

#### Statewide webDEALER Adoption

webDEALER is the department's web-based application for processing title applications that is used by motor vehicle dealers and county tax assessor-collectors. Senate Bill (SB) 604, enacted by the 86th Legislature, requires all county tax assessor-collector offices to make webDEALER available to any dealer requesting to use the application by September 1, 2020.

Statewide webDEALER Adoption is the department's project to prepare county tax offices and dealers for this requirement and deploy programming changes to webDEALER. The department finalized onboarding of a vendor to assist with programming changes to accommodate enhancement requests submitted by users and address outstanding defects. These enhancements will provide additional efficiencies for county and dealer users and increase transaction throughput.

#### TxDMV continued

The VTR Division continues to work with Information Technology Services Division to gather and document requirements for this programming effort, and both divisions are working with the vendor.

In addition to the programming changes to ensure county tax offices are prepared for this requirement, the department worked with county tax offices to ensure every county has an administrator and access to webDEALER. To assist with this effort, the department developed training for initial webDEALER setup, "Getting Started with webDEALER" and indepth training, "Using webDEALER" for both county tax offices and dealers. VTR has communicated the available training to stakeholders and posted the training to the TxDMV website. The department's 16 Regional Service Center Managers have reached out to each county tax assessor-collector's office not currently utilizing webDEALER to schedule time to present these trainings on a more personalized level and to facilitate with questions and answers.

While the requirement to provide webDEALER access to dealers who make a request is not effective until September 1, 2020, there is no prohibition against granting authorization prior to this date. The department encourages county tax assessor-collector offices to begin utilizing webDEALER whenever the county is ready.

#### **Assembled Vehicles**

House Bill 1755, enacted by the 86th Legislature, requires an owner of an assembled vehicle to title and register the vehicle in accordance with Transportation Code, Chapter 731, and administrative rules. The department adopted 43 Texas Administrative Code, Chapter 217, Subchapter L, which outlines titling procedures for the owner of an assembled vehicle. These rules were effective June 22, 2020, to coincide with the implementation of programming changes with the Registration and Title System (RTS) Release 9.7.

Title Services distributed Registration and Title Bulletin (RTB) #010-20 outlining the changes for the county tax assessor-collector offices. In addition to the RTB updates were made to applicable forms that are available on the TxDMV website. Webinars were held for county tax assessor-collector offices on Tuesday June 16, and the webinar recording is available on the TxDMV website. In addition, multiple training sessions were held for Regional Service Center staff who will be reviewing and approving assembled vehicle applications prior to an owner applying for title at a county tax office. Title Services also updated the TxDMV website and communicated these changes to the motoring public. Title Services is in the process of rewriting the Assembled and Rebuilt Vehicle Manual to accommodate these changes and has removed the manual from the TxDMV website in the interim.



#### Regional Service Centers Reopen to In-Person Services

During the month of May, Regional Services and Headquarters personnel were busy preparing for reopening of the department's regional service centers (RSC). Transparent safety barriers were installed, personal protective equipment (PPE) and sanitization supplies were distributed to each RSC, COVID-19 related social distancing floor decals and reminder signs, as well as symptom related warning signs, were installed.


To help ensure customer and employee safety, Regional Services developed a reopening plan that included new and revised twice daily cleaning procedures, proper use of PPE, and new procedures for management of customer flow. All RSC office personnel received training on these procedures prior to offices reopening.

In-person services are now available by appointment, for most transaction types, at all 16 regional service centers. Customers can schedule same day or next day appointments by going to the TxDMV website or by direct link, www.TXDMV.gov/appointment. International Registration Plan (IRP) transactions, NAFTA permits, motor vehicle dealer transactions, and title service company transactions are still being processed by mail, drop-off, email, fax, and/or phone. Overall, customer reaction to the new procedures and safety precautions has been very positive and appreciative.

#### **Mandatory County Training Update**

Senate Bill 604, enacted by the 86th Legislature, included the requirement to implement a training program on the TxDMV automated Registration and Titling System. Training requirements apply to department employees and contractors, county tax assessor-collector (TAC) employees, and full-service deputies.

The training is provided through the department's existing online eLearning system. Initial preparations included a comprehensive review of all previously existing training modules to determine which modules required updates and what new modules required development. New and updated modules were initially launched on December 16, 2019, with additional updates and new modules being added as needed.

Regional Services staff worked diligently with county TACs and county staff to synchronize county eLearning user IDs with corresponding RTS IDs, allowing regional service center managers to verify completed training and enable or disable RTS permissions per established procedures.

All training is required to be completed by August 31, and failure to complete required training by this date will result in suspension of associated RTS permissions until training is complete and verified.

#### Dear Friends,

My predecessor, mentor and friend former Brazoria County TAC Ray M. Cornett passed away suddenly at age 81. He served as Brazoria Co TAC for 28 years. I had the honor of working for him for 16 of those years. Mr. Cornett was a Past President of TACA and was the recipient of the first ever awarded TACA Distinguished Service Award. He served 12 years on the Board of Tax Professional Examiners, including Chair. A pioneer in the education of property tax professionals in our state, his BTPE Number was #2. I credit his faith and confidence for any success I have had as a county official and in my career in general. I cannot imagine what path my life would have followed without his mentorship and his friendship.

#### From the Membership:

Williamson County Tax Office Judy Kocian, Office Administrator

Williamson County Tax Assessor/Collector's office provided significant assistance during the onset of the COVID-19 pandemic. Larry Gaddes and Matt Johnson were leaders of the Logistics team to coordinate the research, purchase, distribution of personal protective equipment. They enlisted the help of Tax Specialist, Becca Bruton, Suzanne Smoczyk, Andrew Dyba, and Property Tax Specialist, Beverley Williams. Becca and Suzanne were on the research and accounting side of the project while Andrew and Beverley managed the distribution pod. This wasn't on a small scale, either. Larry and Matt were locating PPEs for all the Williamson County offices as well as hospitals and clinics. The supplies were stored at the tax office initially; however, it grew to a massive scale, which meant moving to a pod for easier distribution.

With supplies of disinfectants such as Clorox wipes unavailable, Larry and Matt had to improvise in producing something similar. They were able to get the cooperation of a local distillery to provide gallons of 80% alcohol to be used to make disposable disinfectant wipes. With their creative juices flowing, Larry and Matt figured out a way to be able to make these wipes for distribution to various offices. Tax office staff members were tasked with purchasing automotive shop towels and gallon Ziploc baggies in massive amounts. An assembly line of four workers rotating on a two-hour schedule set to work making homemade disinfectant wipes. Two workers cut the shop towels in half using a fabric cutter and put them in groups of 25. The next group oversaw dunking the towels in the alcohol provided by the distillery and wringing out the excess alcohol, placing these in the Ziploc baggies. A fair estimation would be that the tax office produced a minimum of 1,000 baggies (25 wipes in a bag).

Pictures speak a thousand words of the requests that were asked of Larry and Matt during a time of confusion and unknown challenges.

King Ranch is larger than Rhode Island.



### **News from the Property Tax Administration Advisory Board By Randy Riggs**

Reports included the Comptroller's Property Value Study conducted pursuant to Government Code Sec. 403.302, the Comptroller's review of each appraisal district's governance, taxpayer assistance, standards, procedures and methodology, conducted pursuant to Tax Code Sec. 5.102, and consultation pursuant to Tax Code Sec. 26.04(e-4) concerning the notice of estimated taxes to be imposed on an owner's property by each taxing unit, and rules prescribing the form, format and delivery of the notice. The meeting lasted less than 30 minutes. The next meeting was scheduled for May 12, 2020 and was subsequently canceled.
