LIST SERVE CHANGES ARE COMING

Exciting news!!!

Our current listsery will be upgraded to a new platform, called Mobilize, on 04-12-2019. This upgraded platform will offer traditional listsery functionality via email, as well as a web-based platform and mobile app. Here is some important information about what you can expect following the transition.

I will be in touch with everyone with updates. You can expect an email from me one week prior to the transition, the day of the transition and following the transition.

- Our email address will be changing to <u>tac-tax@groups.county.org</u> Please do not use the current email address after the transition is complete or your message will not be received.
- · With the new platform, clicking "Reply" will respond only to that message's sender. Clicking "Reply All" will respond to the whole group.
- When transition to the new platform is complete, you will be sent an invitation email, inviting you to visit our new community via web platform. Upon clicking this, you will be prompted to create a profile and password. Once you complete this step, you can always log into the web platform at tac-community.county.org using these credentials. Please note that Chrome is the best internet browser to use for the web platform. You do not have to register online for the mobile or web platform. You can continue to use the listserv just like it is by using the email address above and doing all of your communications strictly through email.
- Want to stay connected on the go? Download the Mobilize app available for free in Apple and Android app stores. Use the same credentials you used for the web platform.
- All messages sent via email, web community or mobile app will be received through all channels. For example, a message sent via email will
 appear in the web community and mobile app, and a message posted in the web community will be sent via email and appear on mobile app, and
 so on. You can correspond exclusively through email if you wish.

Happy New Year!

Since we have began a new year, here are a few reminders from the TPWD Boat Titling & Registration Program:

Training Opportunities – The TPWD Boat Titling & Registration Program offers training opportunities, both in person at our headquarters facility in Austin and via webinar. These training courses are open to both participating TAC agents who have new staff or would like additional training for existing staff, and to non-participating TAC staff who are interested in learning more about our program. Interested? Call our TPWD Field Liaisons at 512-389-4393 for information.

Expired Decal Inventory – It's time to return all outstanding 2018 decal stock to TPWD headquarters so that your inventory account can be properly credited. Please send all unused 2018 decals (and any prior years you may still have on hand) to: Texas Parks & Wildlife Department, Boat Titling & Registration, and Attn: Becky Peralez, 4200 Smith School Rd, Austin, TX 78744.

New vs. Used – When an asset is being added to TPWD record for the first time, select "New" in the Boat Registration Information & Titling System (BRITS) when the asset is brand new from a dealer or manufacturer, or newly homemade. Select "Used" when the asset has been owned and operated previously (ex: because it was registered/titled out of state, it has been owned and operated on a private lake and never before registered or titled, etc.). All assets already on TPWD record will automatically default to "Used" in BRITS when subsequent ownership transfer transactions take place.

Voids – When voiding a transaction, make sure the Void Request Form is completed <u>in full</u>, including the disposition of any titles/ID cards/decals that resulted from the transaction [ex: Returned (attached), Not Applicable, Not Yet Fulfilled (not yet printed), or Lost or Destroyed], if a follow up transaction is required, and obtaining two signatures on the form.

Processed transactions – All processed transactions should be bundled and mailed to TPWD headquarters weekly, in accordance with the TPWD document packaging procedures, for compliance audit and imaging. Bundles should include:

- All transactions processed the prior week (Monday Friday).
- The appropriate Transaction Activity Reports (TAR) for each day transactions were processed (if there were no transactions processed on a particular date a TAR is not required for that date).
- The cover sheet that includes the Agent Location name and number, and the date range of the transactions in the bundle.
- A Transaction Receipt for every boat or outboard motor transaction processed (make sure the Transaction Receipt is first, followed by the supporting documentation for that transaction behind it).
- Please **do not** include Order Receipts, Account Notices, or Agent Activity / Clerk Activity Reports.

The TPWD Boat Titling & Registration Program would like to thank all participating Tax Assessor-Collector Agents for a successful 2018! We look forward to another successful year in 2019!

TxDMV County Equipment Guide

Need a new workstation in your office? The annual lease cost is much lower than it used to be. That's one of the changes implemented because of the new County Equipment Guide.

The guide is a reference compiled for your use that provides important information related to workstations and certain consumables issued by the department. With over 3,000 workstations currently issued to tax assessor-collector offices and full-service deputies across the state (in addition to printers, routers, and switches), it is important to document requirements and procedures.

The new procedures will take effect on Sept. 1, 2019. However, we implemented one change on Sept. 1, 2018: Lowering the annual workstation cost from \$1,500 to \$361. Many counties have already taken advantage of the new lease cost.

We hope that counties whose budgets may not have allowed for leases at \$1,500 per year will be able to absorb the \$361 annual cost if they need an additional workstation.

The goals of the guide are to:

Provide a comprehensive document to answer questions related to equipment and consumable supplies.

Create a more streamlined and consistent process.

Clearly define the roles and responsibilities of both TxDMV and the tax assessor-collector offices.

The department distributed the guide to the Tax Assessor-Collectors Association of Texas' DMV Liaison Committee for review and comment in early December 2018, and requested a response by Jan. 31, 2019.

TxDMV will evaluate the committee's response and distribute a finalized County Equipment Guide to all TACs for review ahead of the Sept. 1, 2019, implementation date to ensure ample time for planning.

Red Flag Review Policy

TxDMV and the counties play a critical role in combatting fraud. Our Compliance and Investigations Division (CID) has a new policy in place to outline the requirements and process for counties to submit Red Flag review submissions.

It is CID's policy to manage all submissions in an effective and efficient manner to optimize department resources, facilitate communication with county tax assessor-collector offices, and uphold both the TxDMV and CID mission statements.

Performance Quality and Recognition Program (PQRP)

Ten counties applied to participate in the PQRP program for FY 2019! PQRP is a voluntary, multi-level recognition program available to all 254 county tax assessor-collectors.

TxDMV established the program to recognize county tax assessor-collectors who go above and beyond in complying with Texas laws, agency rules, and exceeding expected customer service.

The three levels of recognition are Bronze, Silver, and Gold. Each level requires achievement in the following categories: Business Process, Fraud Prevention, Customer Service, and Training.

Update from Property Tax Assistance Division at the Comptroller's Office

The Comptroller's Property Tax Assistance Division (PTAD) recently published the 2016-2017 *Biennial Property Tax Report*. This report includes the total appraised values and taxable values of taxable property by category, together with the tax rate of each county, municipality and school district in effect for the preceding two-year period. Appraisal districts report this information to PTAD through the Electronic Appraisal Roll Submissions.

Publishing Tax Rates

PTAD relies on the tax rate information posted on county tax assessor-collector websites as required by Tax Code Section 26.16 to verify the information reported through EARS, and uses it in the Property Value Study (PVS). As a reminder, Tax Code Section 26.16 requires the assessor-collector for each county to post on the county website the following information for the most recent five tax years for each taxing unit located wholly or partially in the county:

- 1. the adopted tax rate;
- 2. the maintenance and operations rate;
- 3. the debt rate;
- 4. the effective tax rate:
- 5. the effective maintenance and operations rate; and
- 6. the rollback tax rate

Comptroller Rule 9.1002 requires posting a prominently featured hyperlink, entitled *Tax Rate Information*, on the county's home webpage that links to either a list or a single table of all the taxing units located wholly or partially in the county. If the information is in list format, it must appear in alphabetical order by taxing unit name and each name must link to a table of information as required by Tax Code Section 26.16, organized by tax year with the most recent tax year presented first. If a single table is used, it must appear in alphabetical order by taxing unit name, organized by tax year with the most recent tax year presented first.

Data Visualization

PTAD has recently published three data visualization tools:

- The Tax Rates and Levies Data Visualization Tool allows users to explore and compare property tax rates and levies for counties, cities and school districts.
- The Operations Survey Data Visualization Tool allows users to explore data reported to the Comptroller's office by county appraisal districts regarding their budgets, staffing, appraisal services and operations.

The <u>Biennial Report Data Visualization Tool</u> allows users to explore data as charts and graphs that allow for comparisons across multiple years of reports.

Comptroller Liaison Committee

PTAD and the Tax Assessor-Collectors Association of Texas, Comptroller Liaison Committee, have been working together to gauge interest in developing training and outreach designed specifically for tax assessor-collectors and their staff. "Does My Motor Vehicle Purchase Qualify for an

Agricultural or Timber Exemption?"

It's almost that time again! As a reminder, this is the renewal year for taxpayers holding Texas Ag/Timber Exemption numbers; their current exemptions expire on Dec. 31, 2019. With that in mind, we expect that taxpayers will inundate your local Tax Assessor-Collector (TAC) office with questions regarding their ag/timber number renewals, new applications and how the ag/timber exemption applies to the purchase of a motor vehicle.

One of the biggest issues when dealing with taxpayers who hold ag/timber numbers is that they assume their motor vehicle purchase qualifies for exemption from motor vehicle sales tax, since they are using the vehicle primarily on their farm or ranch. That is, however, a common misconception – as it depends on the type of motor vehicle purchased.

Motor vehicle sales tax exemptions only apply to CERTAIN motor vehicles purchased for use on a farm or ranch. The following is some guidance to help determine whether an exemption applies to the purchase of a vehicle.

Farm Machines, Farm Trailers, Semi-Trailers and Pick-Up Trucks

Farm machines, farm trailers and semi-trailers used primarily for farming and ranching, including machines and trailers used primarily in poultry operations and on feedlots, qualify for exemption from Texas motor vehicle tax.

A farm machine, farm trailer or semi-trailer is exempt from motor vehicle sales and use tax if it is used at least 80 percent of the time in one of the following ways:

Farm Machine – a self-propelled motor vehicle specifically adapted for, and primarily used to:

- Apply plant food and agricultural chemicals in producing crops; or
- To distribute livestock feed in raising livestock.

Farm Trailer or Semi-Trailer – a trailer or semi-trailer designed for and used primarily on a farm or ranch. This does not include a motor vehicle designed for sleeping, dressing, lounging, restroom use or meal preparation, even if used to transport livestock or agricultural products.

If the farm trailer or semi-trailer is used more than 20 percent of the time to transport livestock or tangible personal property (TPP) to and from rodeos, competitions or for similar use, it does not qualify for motor vehicle sales tax exemption.

Pick-Up Truck – a pick-up truck does not qualify for the ag/timber exemption, even if registered with farm plates.

Dealer Transactions

Dealers should be aware that there is not an exemption on the purchase of a pick-up truck. If, however, you come across a dealer submitting an application for Texas title involving the exemption of a non-qualifying motor vehicle, you should advise them that the transaction does not qualify, and motor vehicle sales tax is due by the customer.

2019 is shaping up to be a busy year! With 2018 barely finished, sights have turned towards improvements in preparation for 2020 and all of the elections occurring in between. We are excited about a number of projects that are finally underway.

First and foremost, our office is working on a Forms Consolidation Project in which we intend to create a single Forms Page for all Voter Registration and Election Related forms. We have started migrated forms already and all voter registration forms have been moved and are now available in the consolidated forms index. We will be rolling out additional forms and updates to this website out in phases and forms will be renumbered to match a single forms manual. I encourage all voter registrars to take a look at Chapter 17, the Voter Registration Forms section to familiarize yourself with the new breakdown as we will be talking more about it throughout the spring and summer.

In addition, we have been coordinating with Department of Public Safety (DPS) to obtain additional information to provide voter registrars a new data source that can and will be used in list maintenance activities. We will be implementing the process later this month by which comparisons of information received from DPS for individuals possessing a Driver License or Personal Identification Card who DPS has identified are not citizens of the United States will be conducted and task notification for matching voters will be provided out to each county. The DPS Non U.S. Citizen data will be matched against Active and Suspense voters within the TEAM system, and information will be provided to counties if/when a match is identified between the DPS data and a registered voter in the county. In preparation for this new source of data that will be made available, we have updated the "Cancellations and Reinstatements" and "Matching" mini-manuals on the DocShare site. We encourage all counties to attend one of our free webinars and download and use the available manuals in processing this data.

We have also been working with a number of counties for Election Security Assessments, which are well underway. We encourage all counties to avail themselves of an assessment, paid for by our office, as a health check measure during the spring of 2019. Should you have questions about the process or if you are interested in participating and have not yet started the process, please contact our office.

Another project that is underway is that we will be migrating the DPS Web Portal into the TEAM application. We are working hard to try to have that in place for use in the May Election or shortly after that, so that counties have time to familiarize themselves with the Portal before any potential November Special Election.

Speaking of the May Election, preparation and support for the upcoming May Elections is ongoing. Listed below are some of the key dates for the election:

- Thursday, April 4, 2019 (30th day before Election Day)
 Last day to register to vote for the Saturday, May 4th Election.
- Monday, April 22, 2019 (12th day before Election Day) First day to vote early in person.
- Tuesday, April 23, 2019 (11th day before Election Day)

 Last day to receive an application for a ballot to be voted by mail or an FPCA from a registered voter.
- Tuesday, April 30, 2019 (4th day before Election Day)
 Last day to vote early by personal appearance.
- Saturday, May 4, 2019 Election Day
 7:00 a.m. to 7:00 p.m. Polls Open
 7:00 a.m. to 7:00 p.m. Voter registrar's office is open

Our office will be available on Saturday, May 4, should you need assistance.

Finally, don't forget to <u>MARK YOUR CALENDARS</u> for the 37th Annual Election Law Seminar for County Election Officials. It will be held in Austin, on July 29 - 31, 2019.
