MINUTES

- I. Call to Order At 9:01 Tammy McRae called the business meeting to order.
- II. Prayer and Pledges Kevin Kieschnick led the group in prayer and Shay Luedeke led the group in the pledges.
- III. Official Count of Tax Assessor-Collectors Justin Carothers conducted the official count of Tax Assessor/Collectors in attendance. The official count is 154 members.
- IV. Presentation of Year-End Financials Larry Gaddes presented TACAs financial statement to all members. The statement showed the detailed transactions to include deposites and expenses by month to include account balances for the association's 3 accounts. Some highlighted items included the legislative liaison expense, fund balances, the impact of the cancelled 2020 conference, and the positive impact of vendor contributions. John Ames moved and Michelle French seconded to approve the financials. Motion passed unanimously.
- V. Election of Board of Directors - Mary Ann Waters and the Elections committee conducted the election for the Board of Directors. The floor was opened for nominees beyond those previously submitted. Tammy McRae asked for nominations from the floor for President-Elect. The motion passed unanimously. Tammy McRae asked for nominations from the floor for Vice President Internal. Kristi Roe moved and John Ames seconded that nominations cease and Donna Willis be accepted as the nominee. The motion passed unanimously. Tammy McRae asked for nominations from the floor for Director. John Ames moved and Sherry Mueck seconded that nominations cease and Shay Luedeke and Christine McMurray be accepted as nominees. The motion passed unanimously. Shay Luedeke rapped and Christine McMurray spoke to the group. Discussion was had about board position responsibilities.
- VI. Larry Gaddes introduced the Finance Committee recommendation to increase membership dues. Larry Gaddes moved for all memberships to increase by \$25.00 each. TAC membership would increase from \$150 to \$175, deputies would increase from \$50 to \$75. Wendy Burgess seconded.
