## MINUTES

- I. Call to Order – Bruce Stidham called the meeting to order at 7:46 am.

- IV. Introductions and Guests – Guests included Sarah Lazarowitz, Haley Click, and Katy Regan
- V. End of Conference Report – Sarah Lazarowitz reported that there was a verbal altercation between two employees of the same vendor and requested that they be banned from future conferences. Haley Click commented on her experiences and concerns about the conference.
